On September 16, 2021, Governor Gavin Newsom signed into law Assembly Bill 361. The Bill amends Government Code section 54953 to provide authority and specific requirements for public agencies to hold virtual meetings during a proclaimed state of emergency and remain in compliance with the Brown Act. The Governor's Executive Order N-29-20 expired September 30, 2021, and Government Code section 54953, as amended by AB 361 is in effect until January 1, 2024.
