## 4. Discussion and Information

- A. Fire Academy 2023-2024; Graduating Fall 2023 (December)
  - Review of Fall 2023; Fire 140 EMT consisted of 29 cadets, 19 continued to Fire 142 Firefighter II.
  - \$225 due at the beginning of the course which was successful Spring 2024 vs collecting though out semester and some were not paying
- B. Fire Academy 2024-25 will run 8 months straight; Graduating in June 2024
  - Fall 2024 = Fire 140
  - January 2025 thru Spring 2024 (Fire 142 Firefighter I; Fire 144 Firefighter II, then Fire 148 Capstone Firefighter I

### C. Fire Academy Recruitment

- Currently recruiting 30-45 student each cohort
- Tightening the Fire Academy course schedule is a positive move
- Chief Silva, stated it would be helpful in their recruitment
- Paige reports that students are looking careers that they can be certified within a year; will see an increase in enrollment
- Brett agrees with Paige as they did the same with Post Academy and the enrollment was previously 50-55 vs. currently 120 with a waiting list

- Revising the Fire Academy portion of the website, reflecting the addition State Fire Training fees by course
- Financial Aid does not cover these SFT fees; occasionally a student may receive funds from a separate resource or grant
- Chief Silva, asked about Fire Academy Cadets Funding Resources they have Firefighter Association Fund. Tricia, stated their is a small IVC's Fire Technology/Fire Academy Foundation Fund as well.
- · Chief Bernal, mentioned Fire Association could perhaps help facilitate in the aid
- . Brett mentioned they have the High Speed Driving \$1000 fee, although its paid directly to Sacramento
- Chief Bernal, encourages all the Fire Advisory Members be invited to the Fire Academy Orientation
