The District faces a projected \$6.2 million deficit, primarily due to a 54% rise in Health & Welfare benefits over four years and transfers to Capital Outlay projects, OPEB, and Pension Trust funds. Slight revenue growth and reserves help offset these costs. Board policy requires at least three months (but no less than 16%) of operating expenses in unrestricted General Fund reserves. The deficit aligns with this requirement and allows the District to meet its financial obligations.
