4. Discussion Items

A. AB 705/1705 Update

- Will be including this item for the remainder of the academic year as departments continue to work on this.
- **Math Department - Jill Nelipovich**
 - has been working with the department, they have developed a new CTE math course, considering title.
 - This year or the year after they may create an integrated math not for CTE
 - Working on including activity lab built into the course
 - The new CTE course will be 100 level, transfer level.
- **English Department - Michael Heumann**
 - The department is still discussion what will be done, ENGL 105 is already established providing options for students.
 - The department will stop offering ENGL 008 and 009 in the Spring. There are ongoing conversations in the department regarding the options for those courses such as noncredit and other types of support including referring students to the newly created ESL courses.

B. Active Courses Not Offered within 3 Years - Kristen Gomez

Members to discuss courses that are active in the inventory but have not been offered in over 3 years.

- Some Community Colleges have a rule in place that courses that have not been offered in 3 years are brought forward for deletion; does not mean automatic deletion but they are addressed
- Looking to see if the committee is interested in a report/trigger for review. We need to make sure that courses that are required are offered so that students can complete.
- Members agreed that it would be helpful to have a report; this is intended to support the work of departments.
- The process will be to review all courses from a report provided by the specialist that have not been offered in three years and ask the departments to provide rationale and intention to have the course(s) remain in the active inventory.

5. Information Items

A. Dated Textbook Report - Textbooks over 7+ Years CSU Transferable

- If departments have dated textbooks that are transferrable the request is to update the text.
- Sometimes there are discipline classics being used, just make sure that the version is the most up to date.
- Especially important for general education courses. As we move into CalGETC these courses will go through re-review and if our textbooks are updated we'll be ready.
- The requirement is that at least one text must be within the timeframe for articulation purposes.
